PETITION FOR DISSOLUTION OF MARRIAGE

Comes now the Petitioner above-named and files this Petition for Dissolution of Marriage and for other relief, and in support of this petition, respectfully shows the Court the following:

1. PARTIES IDENTIFIED:

Residency.

Petitioner has been a resident of the State of Illinois and has been a resident of the county of **Erie** for more than ninety (90) days immediately preceding the filing of this petition thereby satisfying the jurisdictional requirements under Illinois law.

Petitioner.

That the Petitioner's full name and address is: **Dave Jones** with social security number **11223344** and **New York State Drivers License Number 1232345** who resides at **11 my street Chicago, IL 12345 United States** . That the Petitioner is of legal age, having been born on **11/22/1960** and is currently unemployed.

Respondent.

That the respondent's full name and address is: **Nora Jones** with social security number **11144332** and **Ohio State Drivers License Number 2938372** who resides at **11 Main Street Chicago, IL 11234 United States** . That the respondent is of legal age, having been born on **11/22/1970** and is currently employed as a **Janitor** by **IBM Corp** located at **1234 employer street seattle, UT 12345 United States** . That the Respondent is a resident of the State of IL, and has consented to the jurisdiction of this Court and has acknowledged service of process and jurisdiction and venue of this Court are correct.

2. MARRIAGE:

That parties were married in **Boston, Middlesex County, Massachussetts** on **11/22/1990**, and lived as husband and wife until such time as they separated ceased to live as husband and wife on **11/22/1995** and they have remained in a bona fide state of separation since that date. That no other Petition for Dissolution of Marriage currently exists in any other county or state.

3. GROUNDS:

Petitioner brings this action for a divorce on the grounds of **adultery** based on the following:
My Wife cheated on me with another man.

4. CHILDREN:

That the following children under the age of eighteen (18) years were born to or adopted by the parties as issue of this marriage and none other is expected:

That **Dave Jones** be ordered to pay to the Clerk of the Circuit Court of **Erie** County, Illinois, a reasonable sum of support, temporary and permanent for the minor children of the parties until further order of the Court.

5. PROPERTY AND DEBTS:

The parties have voluntarily entered into a written Marital Settlement Agreement providing for the division of their property and debts a copy of which is attached as Exhibit "A" and they are satisfied with those provisions. Each party certifies that the Marital Settlement Agreement was signed without duress, force or collusion, and asks the Court to make their agreement the order of the Court.

6. MAINTENANCE:

Spousal support maintenance shall be as set forth in the marital settlement agreement.

7. NAME CHANGE:

The Wife herein does not request that her maiden name be restored.

8. MILITARY:

Petitioner is a not member of the United States Armed Forces. Respondent is a not member of the United States Armed Forces.

WHEREFORE, the Petitioner Prays:

I. That a date be set for a hearing on the claims of the parties, and that process issue if required;

II. That a Judgement Dissolving the Marriage be granted to said Petitioner from Respondent;

III. That the Petitioner be given relief as sought, or that the Marital Settlement Agreement attached as Exhibit "A" providing for the division of their property and debts, and that **Nora Jones** be awarded the temporary and permanent care, custody, control and education of the minor children of the parties, subject to the reasonable visitation by **Dave Jones** be approved and made a part of any final decree issued by the Court and subject to the order of this Court.

IV. That **Dave Jones** be ordered to pay to the Clerk of the Circuit Court of **Erie** County, Illinois, a reasonable sum of support, temporary and permanent for the minor children of the parties until further order of the Court.
